

How a Tennessee Town's Bond Bust Led to a Model State Debt Policy

State treasurers do not usually intervene in the debt decisions of local governments. But when Justin Wilson took over as Tennessee's comptroller in 2009, he saw no other way. Lewisburg, a small town south of Nashville, had become entangled in a risky municipal bond deal. The fallout from the transaction exposed weaknesses in the borrowing practices of many of Tennessee's small counties and cities. Wilson concluded he had no choice but to increase the state's oversight of local government debt transactions to protect Tennesseans from getting socked by sudden increases in borrowing costs. First, Wilson cracked down on high-risk interest rate swaps, a form of

instrument known on Wall Street as a derivative. Then, in an effort that concluded last month, he developed a model debt management policy for local governments. The goal is to ensure that county and city officials—as well as Tennessee residents—clearly understand the risks of debt transactions and the fees paid to make them.

April Luncheon Speaker

For our April meeting, we were fortunate to have Tennessee Board of Regents Chancellor John Morgan. Morgan is married to Donna Morgan; they have two sons, Brian and Kevin. He graduated from Austin Peay State University in 1974, and did graduate work at LSU 1974 – 1976.

John is no stranger to this chapter, and he was happy to come back to speak. The membership was receptive to his timely message on education and its place in society. Mr. Morgan gave a wide range of statistical information on the benefits of a good education and on the quantifiable negative effects of not having a solid post secondary education can have on someone's life.

Morgan started his career in state government as a Research Assistant for the Legislative Fiscal Review Committee in 1976. From 1978 to 1980, he was a Research Assistant in the Department of Finance and Administration, and from 1980 to 1982, he was an Administrative Assistant to the State Treasurer. In 1982 he began working in the Office of the Comptroller of the Treasury as Assistant Director of Bond Finance, and in 1983, as Director of Bond Finance. In 1987 he also became Assistant to the Comptroller, as well as Director of Bond Finance. After a stint in the private sector, Morgan returned to state government as Executive Assistant to the Comptroller of the Treasury, and in January 1999, he was elected Comptroller of the Treasury by the Tennessee General Assembly. He was re-elected to this position in 2001, 2003, 2005, and 2007.

In January 2009, he was appointed to the position of Deputy to the Governor and served in that position until his appointment as Chancellor of the Tennessee Board of Regents on October 1, 2010. Morgan is a member of the American Society of Public Administration and a former member of the Association of Government Accountants.

AGA Names Recipient for Excellence in Government Leadership Award



Richard V. Norment, CGFM, CIA, Assistant to the Comptroller, recently received a well deserved award for Excellence in Government Leadership from the Association of Government Accountants (AGA) at the 8th Annual National Leadership Conference and Exposition in Washington, D.C. The Excellence in Government Leadership Award was formally established to recognize a government professional who exemplifies and promotes excellence in government, outstanding leadership, high ethical standards, and innovative management procedures.

The award was presented in recognition of Richard's distinguished record of service to the Comptroller of the Treasury's office, where he is responsible for the annual audits of all 95 Tennessee county governments. Due to his successful management of the audit process, all 95 counties are now in total compliance with the financial reporting standards outlined by the Governmental Accounting Standards Board in Statement 34.

Mr. Norment has spent his professional career with the Comptroller's office after joining the Division of County Audit as a financial and compliance auditor soon after graduation from college. Mr. Norment progressed through various supervisory audit levels within the division prior to assuming the responsibilities of his current position.

Mr. Norment serves in a key management position for the Comptroller of the Treasury, a constitutional officer elected by the General Assembly. The duties of the Comptroller include the audit of state and local government entities as well as participation in the general financial and administrative management of state government. Mr. Norment was appointed in December 2005 to serve as the office's strategic planning coordinator.

Mr. Norment has held numerous leadership positions within AGA. He served as national president in 2001-2002 and as national treasurer in 1997-1998. He served as president of the Nashville chapter in 1982-1983 and as chair of several committees. He received the Achievement of the Year Award for 1985-1986.

AGA, a national professional association of 15,000+ members, represents every level of government financial management, and the association awards the CGFM to those who exhibit excellence in the specific skills needed for the broad area of government financial management.

Teresa Purcell, Budget Director for Lawrence County, Tennessee, was selected as the winner of the AGA **Distinguished Local Government Leadership Award for 2011**. The award recognizes the outstanding leadership in local government that led to improved financial management practices, policies, systems, or operations and consistently exhibited the highest personal and professional standards.


Since Purcell's employment with the Lawrence County Government in 2004, she has made several significant contributions in government and sound financial management. Her accomplishments include cost savings of over \$4,000,000 for Lawrence County, establishment of accounting and financial management, restructure of the EMS billing system, establishment of internal control policies and procedures, implementation of GASB 34, establishment of a solid waste management and billing system, initiation of several cost saving measures and restructure of the debt service.

Purcell was recognized along with other county officials on the front cover of the July-August 2007 issue of the *Tennessee Public Works* magazine to spotlight efforts to develop a recycling program that concentrated on maximizing the price of materials during economic downturns.

Purcell has an MBA with a concentration in accounting from the University of North Alabama. She is currently enrolled in the Leadership Lawrence County and is pursuing a certification as a certified government financial manager (CGFM).

Watch Out for Text Scams – Jeff Hughes



Beep, *Beep Beep*. So your cell phone just went off and you received a text message like the one in this article. What do you do? Do you call the number, do you text back, or even call the police?

This actually happened on Friday, November 19, 2010, in Lawrence and Giles County, TN. The text started around 4:30 and continued well into the night. The picture in this article is the one that my wife actually received. Luckily for us my wife asked me to look at this message and didn't respond, but that's not always the case.

Employee Resources Credit Union is a local Credit Union based out of Lawrence County with a branch in Giles County. It's not a large credit union, but it does serve a good number of people in the two counties. While the texts have not been traced, it's my belief that the perpetrator was purchasing prepaid cellphones with cash to go undetected. As you can see in the picture, the "from" number and the number to call are two different numbers. A person's first clue this is a scam is that it's a TEXT! Yes, you may receive text messages from your bank, but at no time will one tell you to call them about a deactivated card, fraudulent purchase, etc.

Secondly, the "from" number and the number to call are two different numbers. Thirdly, local banks are not open past 4:30, especially on a Friday.

So far there are two known people that called the number and when they did it asked them to enter their card number, pin number, as well as the expiration date. Hmm – isn't that a red flag?? One customer had \$400 removed and the second lost \$1,500.

Scammers are really trying hard to do anything they can to get your money right now and this is a very testing way of doing that. My wife has never had an account with ERCU, but if you ever receive a text like this you should 1) call the bank to let them know and 2) not respond! In this case, they did not have anyone's personal info but were randomly texting people. If you respond to such a message, you should immediately contact the police as well as the bank. If the bank is closed, your ATM/debit card should have an 800 number on the back so you can report your card lost or stolen.

I know as accountants or financial workers we all are aware to never release our personal information to anyone, but the overall public still is not fully aware of that. Please make sure your family and friends are aware of this. Our elderly and college age students are prime suspects to quick fraud schemes.
